

An Ordinance in Amendment of the Code of the Town of Glocester, Rhode Island related to Medical Marijuana

Chapter 350, Zoning: Article I, Section 350-5 Definitions and Article II, Section 350-11, Table of Use Regulations, Attachment 1 shall be amended.

Section 1. The Town Council of the Town of Glocester hereby ordains:

- A. Chapter 350, Article I, Section 350-5 shall be modified to add the following six definitions:

CAREGIVER CULTIVATION

Marijuana cultivation for medical use only by a single registered caregiver cardholder, as defined by RIGL 21-28.6

COMPASSION CENTER

As defined in RIGL 21-28.6-3, a not-for-profit entity registered under RIGL 21-28.6-12 that acquires, possesses, cultivates, manufactures, delivers, transfers, transports, supplies or dispenses marijuana, and/or related supplies and educational materials, to patient cardholders and/or their registered caregiver cardholder or authorized purchaser.

MARIJUANA STORE

Any retail establishment at which the sale or use of marijuana, medical or otherwise, takes place. This shall not include a compassion center regulated and licensed by the State of Rhode Island, as defined herein.

NON-RESIDENTIAL COOPERATIVE CULTIVATION

A use of land located in a non-residential zone, or of a building, or portion thereof, located in a non-residential zone, for the cultivation of marijuana by two or more cardholders, as defined in RIGL 21-28.6-3

RESIDENTIAL COOPERATIVE CULTIVATION

A use of land located in a residential zone, or of a building, or a portion thereof, located in a residential zone, for the cultivation of marijuana by two or more cardholders, as defined by RIGL 21-28.6-3.

PERSONAL MARIJUANA CULTIVATION

Marijuana cultivation by a single registered cardholder, as defined by RIGL 21-28.6, within his or her residential dwelling for medical use only. This use shall only be permitted as an accessory use to a lawfully permitted residential use. In a mixed use building that contains residential and nonresidential uses, this use shall be contained within the residential dwelling unit only.

B. Chapter 350, Section 350-11, Attachment 1, Table of Use Regulations shall be modified to add the following:
