13. Introducing American Sign Language into the Curriculum

The committee discussed ways to begin to introduce American Sign Language at the elementary level, such as teaching a word a week, as well as teaching students the unified pledge. The intent is to provide elementary students with a foundation so that they may build on potential ASL classes offered at the middle and high school in the future. Ms. Dubois will explore possibilities with teachers and staff at the elementary level.

14. K-5 Health Curriculum and Communication

Ms. Ferreira asked about ways to make the curriculum more transparent to the community. In addition to posting curricula and syllabi on the webpage, it was suggested that content teachers attend a school committee meeting to share how they are teaching subject/curriculum expectations and standards. Ms. Zambarano felt that providing the committee with "scope and sequence" by subject would give them a clearer understanding of what is being taught.

15. Homeschool Community, Communication and ResourcesMs. Dubois explained that that the school district is now offering home school

families a curriculum (*Pearson Connection Academy*), which can be modified to meet the individual learning needs of each child in addition to offering tutoring as needed. Ms. Dubois further clarified that home school families are welcome to borrow books and other resources from the schools.
